SHADAC's State Health Access Profile Updated

SHADAC has released an update of its State Health Access Profile. The State Health Access Profile features indicators of access to health care that goes beyond the more traditional measure of health insurance coverage. SHADAC researchers assembled 14 indicators that measure state resources that enable access to health care for residents. This update provides new data along with comparisons to the previous edition (released in 2004), the nation, and for all 50 states and the District of Columbia.

State Surveys: Minnesota Health Access Survey, 2007

Preliminary results from the 2007 Minnesota Health Access Survey are now available and indicate that the rate of uninsurance among Minnesota residents in 2007 (7.2 percent) remained statistically unchanged from 2004 (7.7 percent). Data on the rates of coverage, sources of insurance, rates of employer-based coverage, and disparities in coverage by race and ethnicities are available. The survey was conducted by Kathleen Call, senior faculty at SHADAC and the Minnesota Department of Health, and included 9,700 Minnesota households. State Surveys: Wisconsin Family Health Survey, 2006

A full report from the 2006 Wisconsin Family Health Survey are now available. The report includes rates of current health insurance coverage, sources of insurance and comparisons between 2005 and 2006 insurance trends. Comparing 2005 with 2006 estimates, there is no statistically significant difference between the percent of residents without health insurance for all of the past year (5 percent uninsured each year). The survey interviewed respondents in 2,440 households which included 6,523 individuals. The report was compiled by the Wisconsin Department of Health and Family Services, Division of Public Health, Bureau of Health Information and Policy.
